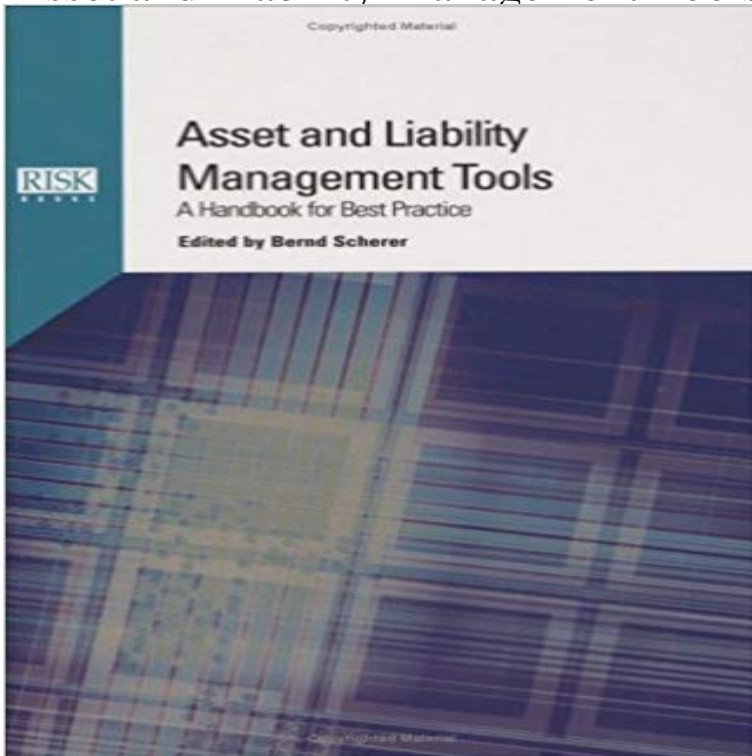


Asset and Liability Management Tools: A Handbook for Best Practice
