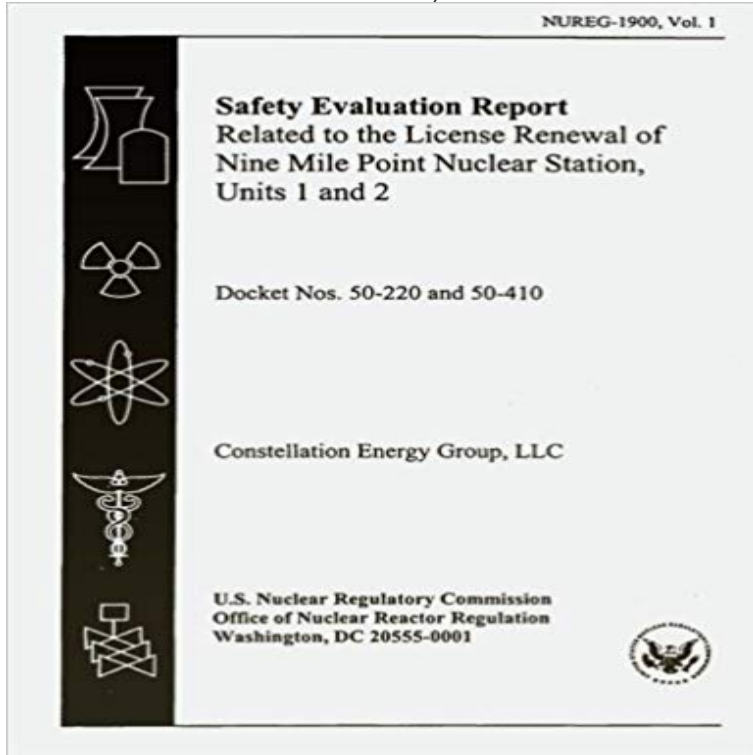


# Safety Evaluation Report Related to the License Renewal of Nine Mile Point Nuclear Station, Units 1 and 2
