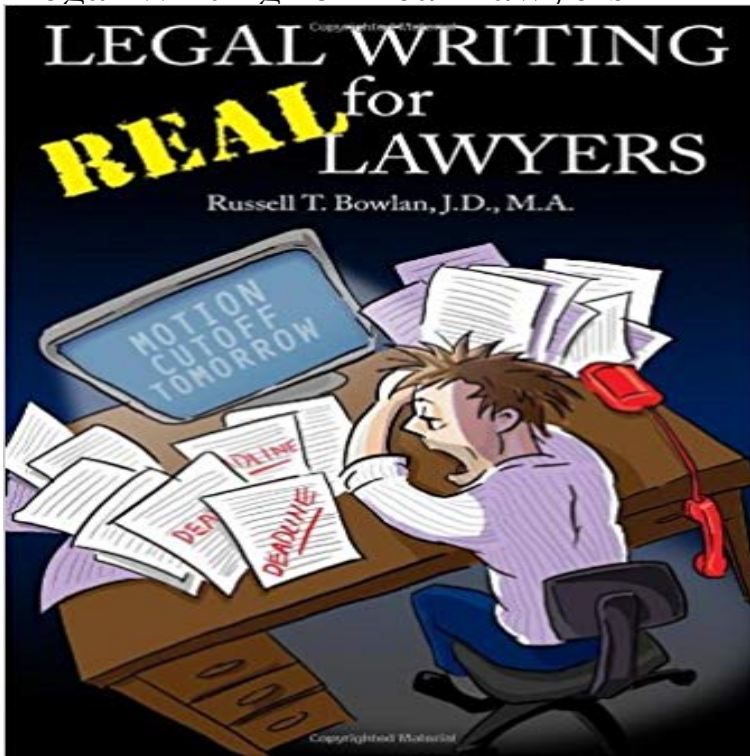


Legal Writing for Real Lawyers
